Golf Cart Use and Operation

The Town of Winterville's Ordinance authorizing the use of Golf Carts on public streets and public vehicular areas was adopted to address the interests of public safety. Golf carts are not designed or manufactured to be used on public streets or public vehicular areas. The Town of Winterville, North Carolina in no way advocates or endorses their operation on public streets or vehicular areas. The Town of Winterville, by regulating such operation, is merely trying to address obvious safety issues, and the adoption of this Ordinance is not to be relied upon as a determination that operation on public streets or public vehicular areas is safe or advisable, if done in accordance with this Ordinance.

All persons who operate or ride upon golf carts on public streets or public vehicular areas do so at their own risk and peril, and must be observant of, and attentive to the safety of themselves and others, including their passengers, other motorist, bicyclists and pedestrians. The Town of Winterville has no liability under any theory of liability, and the Town of Winterville assumes no liability, for permitting Golf Carts to be operated on the public streets and public vehicular areas, under special legislation granted by the State's Legislature.
