The recommended Fiscal Year 2021-2022 budget for the Town of Winterville has been presented to the Winterville Town Council and is available for public inspection on the Town website at [www.wintervillenc.com/budget](http://www.wintervillenc.com/budget). To maintain the safety of Town residents, Town Council, and Town Staff, the Public Hearing scheduled for 7:00 pm Monday, June 7, 2021, will allow limited in-person attendance due to COVID-19 provisions and the meeting will be available electronically. The Town is making every effort to ensure that the Public is able to not only listen to the meeting, but also to participate in the "Public Comment" portion of the Council meeting, while still maintaining Statutory requirements and keeping the public safe, therefore, public comment will be available. People wishing to speak must complete the Public Comment form and submit it to the Town by 5:00 pm on Monday, June 7, 2021. Once completed and the Town has verified receipt, the person wishing to speak will need to dial into the meeting using the instructions below. Persons wishing to speak will remain on mute until such time as it is their time to speak.
