Tips for Seniors in Preparing their Taxes

- Durrent research indicates that individuals are likely to make errors when preparing their tax returns. The following tax tips were developed to help you avoid some of the common errors dealing with the standard deduction for seniors, the taxable amount of Social Security benefits, and the Credit for the Elderly and Disabled. In addition, you'll find links below to helpful publications as well as information on how to obtain free tax assistance.
- ⇒ <u>Standard Deduction for Seniors</u> If you do not itemize your deductions, you can get a *higher* standard deduction amount if you and/or your spouse are 65 years old or older. You can get an even higher standard deduction amount if either you or your spouse is blind. (See Form 1040 and Form 1040A instructions.)
- <u>Credit for the Elderly or Disabled</u> You must file using Form 1040 or Form 1040A to receive the Credit for the Elderly or Disabled. You cannot get the Credit for the Elderly or Disabled if you file using Form 1040EZ. Be sure to apply for the Credit if you qualify; please read below for details. See <u>Publication 554</u>, Tax Guide for Seniors.

Who Can Take the Credit: The Credit is based on your age, filing status and income. You may be able to take the Credit if:

- ⇒ Age: You and/or your spouse are either 65 years or older; or under age 65 years old at the end of 2016 and retired on permanent and total disability before the end of 2017 AND
- Filing Status: Your income on Form 1040 line 38 is less than \$17,500 (single, head of household, or qualifying widow(er) with dependent child), \$20,000 (married filing jointly and only one spouse qualifies), \$25,000 (married filing jointly and both qualify), or \$12,500 (married filing separately and lived apart from your spouse for the entire year).
- And, the non-taxable part of your Social Security or other nontaxable pensions, annuities or disability income is <u>less</u> than \$5,000 (single, head of household, or qualifying widow/er with dependent child); \$5,000 (married filing jointly and only one spouse qualifies); \$7,500 (married filing jointly and both qualify); or \$3,750 (married filing separately and lived apart from your spouse the entire year).
- ⇒ Free IRS Tax Return Preparation IRS-sponsored volunteer tax assistance programs offer free tax help to seniors and to low- to moderate-income people who cannot prepare their own tax returns.

"Mother of the Civil Rights Movement" ROSA PARKS

On December 1, 1955, during a typical evening rush hour in Montgomery, Alabama, a 42-year-old woman took a seat on the bus on her way home from the Montgomery Fair department store where she worked as a seamstress. Before she reached her destination, she quietly set off a social revolution when the bus

driver instructed her to move back, and she refused. Rosa Parks, an African American, was arrested that day for violating a city law requiring racial segregation of public buses.

On the city buses of Montgomery, Alabama, the front 10 seats were permanently reserved for white passengers. The diagram shows that Mrs. Parks was seated in the first row behind those 10 seats. When the bus became crowded, the bus driver instructed Mrs. Parks and the other three passengers seated in that row, all African Americans, to vacate their seats for the white passengers boarding. Eventually, three of the passengers moved, while Mrs. Parks remained seated, arguing that she was not in a seat reserved for whites. James Blake, the driver, believed he had the discretion to move the line separating black and white passengers. The law was actually somewhat murky on that point, but when Mrs. Parks defied his order, he called the police. Officers Day and Mixon came and promptly arrested her.

Mrs. Parks was not the first person to be prosecuted for violating the segregation laws on the city buses in Montgomery. She was, however, a woman of unchallenged character who was held in high esteem by all those who knew her. At the time of her arrest, Mrs. Parks was active in the local National Association for the Advancement of Colored People (NAACP), serving as secretary to E.D. Nixon, president of the Montgomery chapter. Her arrest became a rallying point around which the African American community organized a bus boycott in protest of the discrimination they had endured for years. Martin Luther King, Jr., the 26-year-old minister of the Dexter Avenue Baptist Church, emerged as a leader during the well-coordinated, peaceful boycott that lasted 381 days and captured the world's attention. It was during the boycott that Reverend Martin Luther King, Jr., first achieved national fame as the public became acquainted with his powerful oratory. *Citation credit https://www.archives.gov/education/lessons/rosa-parks*

Watch out for fake Winterville NC Utility bill pay site.

It has recently come to the Town's attention that there is a secondary unofficial website accepting payments for Town of Winterville utility bills. *Doxo* is a bill pay service that charges a large fee for making payments using their service. They are simply a check writing service and is not in any way affiliated with the Town of Winterville. They are charging customers around seven dollars to write the Town a check on your behalf. There checks can take as long as seven days to reach our customer service staff for payment processing. To reach official Town of Winterville online payment services, we recommend using a credit card at the direct bill pay service website of https://
billpay.wintervillenc.com. Using the billpay site, you will only incur a \$2 convenience fee. Most importantly your payment will reflect on your account the same day unless received after 5 p.m. Any payment received after 5 p.m. will reflect on your account the next business day.
